## 5. Firefighting measures

### 5.1. Extinguishing media

#### Suitable extinguishing media

Recommended: alcohol resistant foam, CO<sub>2</sub>, powders, water spray/mist

#### Non suitable extinguishing media

### Advice on protection against fire and explosion
